 - Barna: Now general input is needed for strategic planning of the H2020 WP. Proposals for specific topics will be needed in a second step only
 - Liisa: Suggestion to collect keywords to frame the collection of case studies
 - Corinne: Suggestion to make a horizontal analysis of research projects that deal with case studies as a start
 - Philipp: Suggestion to align our work with that of the thematic WG of the bioeconomy Panel, since they are also doing a case study collection
 - Barna: Case studies of the SWG should be from a Member State perspective rather than from an industry perspective

- Action Point: Organise a meeting with all groups working on sustainability i.e. during the Torino Bioeconomy Stakeholder Conference
- Lasse share the Danish experience of coping with the topic of adapting Environmental, Energy, etc
 legislation to sustainability requirements: DK conducted a study on the topic and came to the
 conclusion that it would take huge amounts of time and other resources to proactively regulate a
 moving market. Thus it was decided to follow a reactive approach. The DK bioeconomy panel will
 identify barriers and propse action to the DK Ministries. The Minitries will decide if a need for action
 is present.
- Lasse presented the development of a bioeconomy in DK
 - Strategic Framework is to prepare DK for a future market pull in the biobased sector as regards supply of biomass and its sutainability
 - A bioeconomy panle is in place since autom 2013
 - For solid biomass industry is obliged to install a voluntary scheme for sustainability reaching at NL and UK standards at a minimum. In case of non-compliance, binding regulation will be implemented on national level.
- State of development in the actor mapping
 - Action Point: Philipp to contact SWG members to contribute to the actor mapping during July
- Corinne presents state of development in the Work Plan Part B
 - Spot to be reserved (16.00 to 18.00) for stakeholder feedback is organised during the Torino SWG meeting
 - A creative workshop on new economic tools and models for the bioeconomy transition to be organised during the 2016 Bioeconomy Stakeholder Conference under the Dutch presidency (B21 of Work Plan)
 - Possibilities to organise a workshop with researchers engaged in public policy for bioeconomy issues (B11 of Work Plan). Event in the frame of for example Sat-BBE, BIO-TIC or BiomassPolicies or other projects? To be checked.
 - o Brochures on the bioeconomy (B32 of Work Plan): Brochures of ca. 10 Pages. One for higher education lecturers and one for lower education/students.
 - Barna suggests that colleagues in national ministries could also be a target group
 - Stefan will contribute with examples from Germany

• Introduction of guests

Hans Langeveld: Director Biomass Research, Wageningen. His major focus is on sustainable biomass production and its utilisation in biofuels and materials.

Christine Bunthof: Wageningen UR. She is involved in European Bioeconomy Panel, JPI FACCE, Platform and Eranet Bioeconomy

Saske Hoving: Netherlands Enterprise Agency. She is National contact point for the European research program Horizon2020 for the themes Agro/food/bioeconomy (SC2) and Research Infrastructures.

Part C of workplan: Joined questionnaire

Hans Langeveld gave a presentation about the Joint Survey on National Bioeconomy Strategies. The survey is aimed to collect national information about Bioeconomy policies and National Research & Development programs. It is a joint action between JRC (Damian Plan is contact person) and SCAR (Philip von Bothmer and Jan van Esch are contact persons). Hans will finalize the questionnaire according to suggestions given by the audience. The final version of the questionnaire will be send before the end of June to all 28 national contact points and SCAR members. The questionnaire has to be send back to Hans before half of August.

Questions/remarks of the audience:

Q2: add water reduction at 'Environmental protection'

Q4: list only public/national funding and not private money

Q4: change 'Fishery' into 'Marine life (e.g. fishery, salt and fresh water)'

Q4: change 'Food/feed use of biomass' into 'Biomass use along food/feed chain'

Q4: add 'Pharmaceuticals' under 'Industrial uses of biomass

Q4: add 'bioeconomy related to recreation, ecosystem services'

Q5: include the word 'innovation'

Q3 page 6: add international clusters and list which countries are involved

General: only fill in the questionnaire when you have expertise, otherwise leave blanc.

General: not in all countries the government has a good overview; in e.g. Hungary the non-governmental organisations have a better overview. The questionnaire will initially only be send to representatives of the government.

• Connection to stakeholders

ERA-net

Christine Bunthof gave a presentation about the progresses that have been made by PLATFORM. PLATFORM brings together the ERA-Nets from FP6 and 7 at the area of bioeconomy with the aim to improve exchange and cooperation between ERA-Nets. At the moment the follow-up of PLATFORM is being prepared (deadline 26 June). Christine brought hard-copies of the book with an overview of all Bioeconomy ERA-Nets. This book is also <u>electronically</u> available. There will be an electronic database available in 3 months.

Questions/remarks from the audience



- Liisa Saarenmaa: is it possible to have partners outside Europe? Answer: yes, quite a number of ERA-Nets have partners outside Europe (or outside the Member States). Eastern Europe is not involved enough and a master class will be organised to help with this.
- Saske Hoving: is it possible to search the electronic database by country? Yes, that is possible. Answer: also Netwatch is doing this.

A new quest arrived: Marc Nellen (Policy Advisor Biobased Economy at Ministry of Economic Affairs, NL). He joined the OECD workshop "Sustainable Biomass Drives the Next Bioeconomy" held in Paris this month. Topics discussed were measurement tools like LCA and economic approach to measure sustainability

Bioeconomy Panel

3 Working groups, deliver concept report by September

- Observatory
- Market uptake
- Biomass supply aspects

The market group will gather Information op 15 topics/cases and general recommendations will be made. Entrepreneurs and researchers will be interviewed.

Business cases by SCAR have overlap with the thematic working group on market.

SCAR foresight

The 4th foresight exercise will be launched. Five experts will work for 1 ½ year on the concept covering bioeconomy. Five more experts will be preselected. The foresight study will have contact with the SCAR strategic working group on biomass.

SCAR CWG bioreffinery

Stefan Rausch gave an update. The member states all use different instruments. In a next meeting held in Wageningen this information will be brought together.

Unfortunately not all member states were present. The work program will be launched on 9 July (will also be web-streamed). The day before an NCP info day will be held in Brussels. On 2 September a partnering event will be organised.

SAT BBE

Hans van Meijl (business developer, Wageningen UR) gave a presentation about the FP7 project SAT BBE (Developing A Systems Analysis Tools Framework for the EUR Bioeconomy).

Questions/remarks from the audience:

Jan van Esch: What type of research do we need. Answer: first look back at what has been done, however this is very costly. Case studies.



Corinne Bitaud: in workplan is stated a workshop will be held with economic scientist on tools that are ready to transfer to policy makers. Suggestion to work together with SAT BBE. Corinne and Hans will keep in touch.

Juan Carrasco: concerning the Malaysian project. Are negative environmental aspects taken into account? Does this indirectly support production of palm oil? Effect on ecosystems are taken into account.

Stefan Rausch: weighing of drivers is a political decision. Data from the survey could give input. Scenario building: what kind of world do you want to live in.

- Food security (suggestion to narrow down this theme because it is too broad)
